**Annual Report to Governor for FY2025**

The Mississippi State Board of Physical Therapy is charged with safeguarding the public's health, safety and welfare preserving and protecting individual life and health, promoting public interest and welfare by statute (73-23-43). It establishes minimum qualifications and creates exclusive titles corresponding to the level of qualifications for individuals who wish to offer physical therapy services to the public.

**Board Members:**

Currently, the Board is composed of the following seven members, appointed by the Governor and conferred by the Mississippi State Senate.

The Board receives legal support from the Mississippi Attorney General's Office.

The Board staff is bonded annually per HB 136, approved by the Governor on April 6, 2021, Section 1 (1) *Notwithstanding any other provision of law to the contrary, any public officer or employee handling or having the custody of public funds, by virtue of his or her office or employment, shall give an individual bond or be covered by a blanket bond of not less \$25,000 unless a specific amount is otherwise required by law.*

The Board will meet each quarter in 2026 for a total of four (4) meetings. All meetings are scheduled to be held at the Board office located at 840 East River Place, Suite 503, Jackson, MS 39202. If there are any changes to the meeting schedule, public notice is given in compliance with the Open Meetings Act. Teleconference or Zoom attendance is allowed and in accordance with state law.

**Budget & Expenditures:**

The Board is operating during Fiscal Year 2025 with a budget of \$353,517.00. Fiscal Year 2025 reflected revenue of \$432,788.00 and expenditures of \$290,159.00.

Licenses are renewed bi-annually, and half of the license holders are required to renew each year which ensures the agency has a consistent revenue stream.

**Licensed Physical Therapist Practitioners:**

**Continuing Competency:**

Each licensee is required to complete additional education to provide the highest quality services to Mississippi residence. This is to facilitate the use of advancements and current trends in physical therapy clinical and administrative practice. Unless continuing competence is prorated at the time of licensure, there is a requirement of thirty (30) CCUs with three (3) of the hours in ethics every two years.

**Mississippi Jurisprudence Examination:**

The examination assesses an applicant's knowledge of the legal requirements for practicing physical therapy within the State of Mississippi.

A total of 351 individuals completed the Mississippi State Law Examination during Fiscal Year 2025.

**Performance Audits of Physical Therapist Practitioners:**

On a quarterly basis, physical therapist practitioners from a different region of the state are randomly selected for inspection. The Board staff or a designee enters and makes inspections of places where physical therapy is practiced from a Board approved check list. The list includes inspecting and/or copying any record pertaining to clients or the practice of physical therapy including a posting of all practitioner licenses.


**Military Family Freedom Act (73-50-1):**
